Wolf Administration: New Machining and Robotics Apprenticeship Opportunities Available in Allegheny County





This funding will support the governor's commitment to expanding job training-related opportunities throughout Pennsylvania.

The Pre-Apprentice and Apprenticeship Grant Program is a statewide program that offers assistance to registered apprenticeship programs. The program's goal is to increase apprenticeship availability to Pennsylvania employers to assist them with their talent recruitment and development.

Wolf Administration Announces \$96 Million in Pandemic Relief for Small Businesses



Governor Wolf has approved an additional \$96 million in state grants for Pennsylvania small businesses that were impacted by the COVID-19 shutdown. Through the COVID-19 Relief Statewide Small Business Assistance Program, over 10,000 businesses have been approved for \$192 million in grants.

The <u>COVID-19 Relief Statewide Small Business Assistance</u> funding was developed in partnership with state lawmakers and allocated through the state budget, which included \$2.6 billion in federal stimulus funds through the Coronavirus Aid, Relief and Economic Security (CARES) Act, of which <u>\$225 million</u> was earmarked for relief for small businesses.

The <u>Department of Community and Economic Development (DCED)</u> distributed the funds to the <u>Pennsylvania Community Development Financial Institutions</u> (CDFIs), which are administering the grants.

Gov. Wolf, Sec. Levine Amend Guidelines On Safe Gathering Limits

EVENT AND GATHERING CAPACITY INCREASE

Starting Friday October 9, indoor + outdoor group limits will expand based on maximum occupancy of venues.

CAPACITY LIMITATIONS

Indoor 0 - 2,000 people 20% of maximum capacity

2,001 - 10,000 people 15% of maximum capacity

10,000+ people 10% maximum capacity - 3,750 maximum



2,001 - 10,000 people 20% of maximum capacity

10,000+ people 15% maximum capacity - 7,500 maximum

Social distancing, masking and other mitigation measures should still be enforced per CDC guidelines.

If a space doesn't have a defined occupancy guideline, it is limited to 25 people per 1,000 square feet.

These limitations do not apply to religious gatherings

* Guidelines are subject to change as necessary to adapt to PA's COVID-19 situation.



Venues must require attendees to comply with 6-foot social distancing requirements, to wear masks or face coverings, and to implement best practices such as timed entry, multiple entry and exit points, multiple restrooms and hygiene stations. Venues and event planners can review the <u>CDC Events and Gatherings Readiness and Planning Tool</u> for additional information regarding best practices.

When not hosting events, occupancy restrictions outlined in the <u>green phase</u> of reopening continue to apply to businesses in the commonwealth.

Any gathering restrictions established by local authorities, such as the ones established in Philadelphia and State College, remain in effect.

Drive-Up Food Distribution



Greater Pittsburgh Community Food Bank will be hosting a Drive-Up Food Distribution on **Tuesday, October 13 from 5 p.m. – 7 p.m.** (one share at least 50 pounds of food per reservation). The Food Bank will be able to serve up to **600** vehicles at this distribution. For additional food, please contact your local food pantry or contact the Food Bank for information about how to find a pantry near you. You can find a pantry by using the <u>"locator" tab</u> on our website.

WHAT: Drive-Up Food Distribution

WHEN: Tuesday, October 13 (5 p.m. - 7 p.m.)

WHERE: Pittsburgh Mills Galleria; 590 Pittsburgh Mills Blvd., Tarentum, PA 15084

Please make a reservation in advance of the event. Reservations allow us to serve you better by controlling traffic and making sure we have the right amount of food. Your information will only be used to provide you food and help us improve your service.

Reservations open four weeks before each event, and close at 5:00 p.m. the day before the scheduled distribution. We will bring a limited number of additional food shares to be distributed on a first come, first served basis. It is highly recommended that you make a reservation, as this is the only way to guarantee you will receive food.

Reservation Instructions

- Select the date of the event you would like to attend.
- Provide your name, email address, and license plate number.
- Click "Begin Reservation." On the next screen, answer the questions to complete your reservation.

There are no exceptions to one reservation getting one share of food. For one car to get two or three shares of food, the car must have more than one family or household. Each household must complete a separate reservation. The same car and license plate can be used up to three times for the same event.

MAKE A RESERVATION

The start time, 5 p.m., is the soonest you will be allowed to enter the distribution line. You must arrive in the vehicle used to make this reservation. As long as you arrive in a vehicle with a reservation between the start time and the end time of the event, you will receive food. The distribution will end promptly at 7 p.m. Drive-up service will be discontinued at that time.

The Food Bank is asking individuals to follow these guidelines:

- For everyone's safety, individuals attending the distribution must stay in their vehicles at all times. This will help us maintain six-foot social distancing guidelines. Leaving cars to socialize is strictly prohibited.
- After pulling into "distribution row", please put your vehicle in park and unlock your trunk or backseat for food to be loaded. Volunteers will not load food into vehicles until they are in park. Please stay in your vehicle.
