BASIC EDUCATION FUNDING COMMISSION

ast year, I was a member of the Basic Education Funding Commission (BEFC), a bipartisan, bicameral commission tasked with recommending changes to the way that we fund our public schools here in Pennsylvania. This work was especially important because, in February, the Commonwealth

Court handed down a landmark decision finding that Pennsylvania has been unconstitutionally underfunding and inequitably funding our system of public education for years. The Court further ordered the General Assembly to fix this system of funding so that every Pennsylvania public school student has access to a comprehensive, effective, and contemporary education.

After several months of hearings, hours of testimony, and hundreds of pages of documents, the BEFC released its final report. A full copy of that report, as well as recordings of the hearings, and all testimony and materials can be found on my website at

I ultimately voted against this final report because of a moral conviction that the future of Pennsylvania depends on getting our system of public education to not only pass constitutional muster, but to exceed it – from Pre-K to higher ed.

We have spent decades defining the problems in education. And while legislators have talked in circles, generations of kids continue to suffer under an unconstitutional system. I wanted this Commission to define the solutions and fight for those solutions to happen now. The majority report did not go far enough in doing that.

I could not in good faith vote for a compromise report that ultimately serves as the starting point for the 2024-25 budget negotiations. I do not want the public to look at a unanimous Democratic-only report and believe that it represents our shared goals. It does not. A unanimous Democratic-only report risks setting the ceiling for negotiations, and the adopted report is closer to my floor. ■

CELEBRATING CAREER AND TECHNICAL EDUCATION

ebruary is Career and Technical Education (CTE) month, but we celebrate this amazing educational programming all year long! CTE gives students the opportunity to get career training and certification, often at reduced or zero cost to them, while still in high school. These students are getting a head start on their next steps, whether that's

finding a job, entering an apprenticeship, or going to a two- or four-year college.

PROTECTING PENNSYLVANIA PATIENTS FROM CORPORATE GREED

I am a co-sponsor of **SB 1000**, legislation from Senator Judy Ward and Senator Tina Tartaglione that would regulate Pharmacy Benefit Managers (PBMs).

Increasingly, pharmacies are reporting that reimbursements no longer cover the costs of purchasing drugs, let alone the costs of dispensing prescriptions to customers. These cost challenges mean that pharmacies run the risk of not being able to stay open – and the risks are even higher for small, local pharmacies.

This legislation would create more oversight for PBMs on a state level by developing a process for hearing and resolving complaints against



PBMs by pharmacies. It will also require PBMs to report the amounts of rebates and payments received from drug manufacturers and how those rebates and payments are distributed to the Insurance Department. The legislation will also limit or ban several practices by PBMs, including patient steering, spread pricing and retroactive recoupment of money paid by the PBM to the pharmacy.

Corporate greed should not stand between Pennsylvanians and their prescriptions. PBMs currently act as an unchecked, unregulated middleman in the pharmaceutical industry. We need to act now before more pharmacies go out of business. These pharmacists know their regular patients extremely well and are a key member of their health care team. Supporting these small businesses and protecting these health care relationships is a priority for me.

EXPANDING PROPERTY TAX RELIEF FOR SENIORS

WHAT IS THE PROPERTY TAX/RENT REBATE?

It is a Pennsylvania program providing rebates on property tax or rent paid the previous year by income-eligible seniors and people with disabilities. The program is for income-eligible Pennsylvanians age 65 and older, widows and widowers age 50 and older, and people with disabilities age 18 and older. When calculating total income, the PTRR program counts half of your Social Security Income.

WHAT'S NEW TO THE PTRR PROGRAM?

Thanks to the first expansion of this program in almost 20 years, nearly 175,000 more Pennsylvanians qualify for a property tax or rent rebate. Additionally, many of the 430,000 Pennsylvanians who previously qualified under the program's prior guidelines will see their rebates increase. The key changes are as follows:

- The income cap for homeowners has increased from \$35,000 to \$45,000,
- The income cap for renters has increased from \$15,000 to \$45,000,
- The maximum standard rebate has increased from \$650 to \$1,000,
- . The income cap will automatically increase along with inflation in years to come.

TO APPLY FOR A PROPERTY TAX/RENT REBATE, YOU WILL NEED:

- · Proof of identity (first time filers only);
- Documentation showing all income received in 2023, including Social Security Income, retirement funds, or other interest bearing accounts;
- · A completed PA rent certificate (for renters only);
- Bank account and routing information if you would like direct deposit.

For homeowners only:

- · Proof of payment/receipt for Allegheny County taxes
- · Proof of payment/receipt for local municipality taxes
- · Proof of payment/receipt for school district taxes

HOW TO APPLY

You can apply for the Property Tax/ Rent Rebate program online, by mail, or in-person. The Department of Revenue advises that submitting your application online through myPATH is the fastest and most secure process. You can access MyPATH here: https://mypath.pa.gov/_/

IMPORTANT DATES

The application deadline is June 30, 2024, and rebates are set to begin rolling out early July 2024. Again, the Department of Revenue is encouraging eligible Pennsylvanians to apply early, especially first-time applicants.

For the first time in almost 20 years, Property Tax/Rent Rebate Program for seniors has been expanded! Nearly 175,000 more Pennsylvanians now qualify for a rebate and maximum rebates available have nearly doubled.

My office helps hundreds of individuals file for their rebates every year, and we constantly hear how much our neighbors rely on this program to help make ends meet. I was proud to vote for **HB 1100** and support this expansion as an important first step towards providing property tax relief to the most vulnerable among us. The Property Tax/Rent Rebate program benefits eligible Pennsylvanians aged 65 and older, widows and widowers aged 50 and older, and people with disabilities aged 18 and older. The new income eligibility threshold is **\$45,000 for both homeowners and renters**. To calculate income, only half of Social Security income is included.

If you meet the current eligibility criteria and need help filing your PTRR or have questions about whether you qualify, please contact my office. We are happy to help you with filing your PTRR! You can also file your rebate online at **www.mypath.pa.gov/_/**. The deadline to file for your 2023 rebate is June 30, 2024.

REPLACING YOUR HARD-TO-READ LICENSE PLATES

Is your license plate peeling, blistering, or discolored? You can be pulled over and fined if any of the letters or numbers on your plate cannot be read from 50 feet away. But you can have your hard-to-read license plate replaced for FREE! Last year, we held a hard-to-read license plate replacement

event at our Natrona Heights office. The Harrison Township Police Department was on hand to complete forms and we were able to help over 100 drivers replace their peeling plates.

If you couldn't make it to the event but still need a replacement, we can help! Stop by or call either of our district offices to get a form that you can fill out at your convenience and have your local police department complete. You can then return the form to our office for processing and a new plate will be mailed to your address free of charge. WHOLE HOME REPAIR PROGRAM SUCCESS



In February, I joined Congresswoman Summer Lee, Allegheny County Executive Sara Innamorato, and my Senate and House Democratic colleagues from across the state to celebrate the successes and talk about the lessons we've learned from the first year of the Whole Home Repairs Program, which provides grants and forgivable loans to low-income families and seniors to complete repairs on their homes.
